# Society of Industrial and Office REALTORS (SIOR) Series D16

In 1922, the National Association of Real Estate Boards' (NAREB) Board of Directors approved the formation of an industrial division within NAREB's structure. In 1938, the Industrial Property Division disbanded, but was replaced in 1941 with the creation of the Society of Industrial REALTORS® (SIR) as an affiliate of NAREB. "Despite the continued growth of industrial real estate, its specialists had little representation within NAREB. With this in mind and anticipating the increased need for industrial spaces on account of the outbreak of WWII, SIR administrators built the concept for an organization that would lead to their success." Though SIR's contributions in assisting the War Department during WWII are noteworthy, the institution's greatest success is in professionalizing the field of industrial real estate. In 1986, SIR changed its name to the Society of Industrial and Office REALTORS® (SIOR).

Today, SIOR has about 4,000 members representing 49 countries worldwide. For over 80 years, SIOR has succeeded in spreading knowledge and providing networking opportunities to industrial and office real estate agents. Real estate professionals who earn an SIOR designation are globally recognized by corporate real estate executives, real estate brokers, and lenders, to have the highest level of experience and skills within the field of industrial and office real estate. SIOR is dedicated to "providing outstanding professional services, publications, and educational programs" to its members, both local and international.
