In 1936, the Board of Directors of the National Association of Real Estate Boards (NAREB), approved the creation of the National Real Estate Foundation (NREF). The purpose of the organization was to conduct research and provide educational activities in the field of urban real estate and community building. In 1939, NREF assisted Northwestern University in organizing a college known as the "Urban Land Institute". The Institute focused on research on urban planning, urban land use, and problems of interest to owners of urban real estate. The college became a separate organization, the Urban Land Institute (ULI), in 1940.

Today, ULI has over 45,000 members from over 70 countries around the world. It is the "oldest and largest network of cross-disciplinary real estate and land use experts", dedicated to having a transformative impact on urban development and global community building. ULI continues to "provide responsible leadership in the use of land in order to enhance the total environment".
