### Standard of Practice 10-5

REALTORS® must not use harassing speech, hate speech, epithets, or slurs based on race, color, religion, sex, handicap, familial status, national origin, sexual orientation, or gender identity.



## Standard of Practice 10-5 – A Two Step Process

**Step 1:** Is the speech harassing speech, hate speech, epithets, or slurs?

**Step 2:** If so, is the speech based on race, color, religion, sex, handicap, familial status, national origin, sexual orientation, or gender identity?



### **Application of Standard of Practice 10-5**

Objective, not subjective

Clear, strong, and convincing evidence is the burden of proof the complainant must provide.

**Context** is scrutinized as with any allegation of a violation of the Code of Ethics.



### Appropriate Interpretation of Standard of Practice 10-5 and Statement of Professional Standards Policy 29

Appendix XII to Part IV, Code of Ethics and Arbitration Manual

Additional guidance with further explanation provided regarding "harassment", "hate speech", "epithets" and "slurs".



### Explanation and Guidance for Standard of Practice 10-5 Examples of Harassment Include, but are not Limited to:

NAR's Code of Conduct and Anti-Harassment Policy Epithets, slurs or negative stereotyping; threatening, intimidating or hostile acts; denigrating jokes; and the display or circulation of written or graphic material that denigrates or shows hostility toward an individual or group based on a protected characteristic.



### Context Matters - There is No List of Words or Phrases that Would Result in an Automatic Violation of the Code

The following examples have not been determined by the National Association to be violations of Article 10.

The following examples are provided merely to generate discussion.



# Negative Stereotyping and Written or Graphic Material Denigrating or Showing Hostility Toward an Individual or Group Based on a Article 10's Protected Classes.

### Negative Stereotyping

Depicting on social media a picture of Kobe Bryant and his daughter with a statement, "First black man to leave and take his child with him."



#### **Explanation and Guidance for Standard of Practice 10-5**

Merriam-Webster's definition of "hate speech"

Speech that is intended to insult, offend, or intimidate a person because of some trait (as race, religion, sexual orientation, national origin or disability).



### Speech that Insults, Offends, or Intimidates Based on a Trait Relating to Article 10's Protected Classes

#### **Hate Speech**

Those (religious group) are the scum of the earth; we should take every opportunity and any means available to drive them out of our community.



#### **Explanation and Guidance for Standard of Practice 10-5**

Merriam-Webster's definition of "epithet"

**Epithet**: **Ia.** a characterizing work or phrase accompanying or occurring in place of the name of a person or thing; **b.** a disparaging or abusive word or phrase.



# A Characterizing Work or Phrase Accompanying or Occurring in Place of a Name of a Person or Thing; Disparaging or Abusive Word or Phrase

### **Epithet**

That (epithet relating to national origin) is disgraceful; just look at those clothes - "Go back to where you came from!"



#### **Explanation and Guidance for Standard of Practice 10-5**

Merriam-Webster's definition of "slur"

**Slur**: **1a.** insulting or disparaging remark or innuendo: ASPERSION, **b.** a shaming or degrading effect: STAIN, STIGMA.



### An Insulting or Disparaging Remark or Innuendo: Aspersion; a Shaming or Degrading Effect: Stain, Stigma

#### Slur

That (reference to sexual orientation) is not welcome in our neighborhood; those people are perverted.
