Aligned with SLIEC's purpose of determining and administering hot topic idea exchanges, we ask that presentations center around creativity and innovative practices that are easily adaptable by other associations.

Please review the background and selection process that includes the criteria taken into consideration when selecting presentations. If selected, NAR staff will notify state presidents, state presidents-elect and the individual(s) that submitted the presentation ("submitter(s)") as to whether they have received an invitation to present at the State Leadership Idea Exchange Council Opening Session or the State President-President-Elect Information Exchange ("Information Exchange"). Please keep in mind that presentations not selected for the Opening Session will be considered for the Information Exchange. We will post all presentations on nar realtor for the benefit of everyone. Please also note that the Council leadership has also designated breakout session time, subsequent to the Opening Session to allow for continued dialogue, sharing and networking. There is also an opportunity to continue dialogue at the Information Exchange.

Background Information – SLIEC vs President/ Presidents-Elect Information Exchange: The difference between the SLIEC Opening Session, (Tuesday, May 15, 1:30 p.m. – 2:10 p.m.), and the Information Exchange, (Friday, May 18, 9 a.m. – 11 a.m.), is that the former meeting consists of top pick ideas shared among a larger crowed with NAR leadership present. The latter meeting consists of top pick ideas shared among state presidents and state presidents-elect only; NAR leadership and state association executives are not present. Additionally, during either the Opening Session or the Information Exchange, Council leadership may invite guest speakers to present on various topics that are of value to the Council.

Submission Timeline:

- Detailed ideas/reports are due to Council leadership by: **Monday, April 9, 2018** (submission details provided on the submission form).
- On **Monday, April 16, 2018**, NAR Staff will notify selected state associations via email as to whether the state association is invited to present at the SLIEC Opening Session or the Information Exchange.
- If your association accepts the invitation, all presentation materials are due to NAR staff by Thursday, May 3, 2018.

Submission Criteria:

The chairs and vice chairs of the respective forums (i.e. small state, medium state and large state) evaluate presentations on each of the following four criteria:

- Originality
- Relevance
- Ability to inspire action
- Overall quality
